4. *Who did Paul use to speak on his behalf? (v. 10) How long a time did Paul indicate that he had been in Jerusalem? (v. 11) What was the nature of Paul's conduct that he described while in the temple, synagogues or in the city? (v.12)*

5. *What did Paul think of the validity of the charges which Tertullus and the Jews brought against him? (v. 13) What things did Paul confess that he did? (vs. 14-18)*

6. How did Paul describe "the Way"? (v. 14) How profound do you find his confession? (vs. 15-17) What did Paul indicate as to the reason he came back to Jerusalem? (v. 17)

7. What did Paul say with regard to those who supposedly had been unfavorably treated by him? (v. 19) What one statement did Paul refer to as to a possible reason for objection to his conduct? (v.21) Can you think of a time whenever Paul testified or gave a sermon that he didn't include the cross and Jesus' resurrection?
